



Business Description

Linea Directa Aseguradora SA is engaged in insurance and reinsurance activities in the motor, home, and other non-life segments. The company has five operating segments; The motor segment includes private motor insurance and motorbike insurance, The home segment includes multi-risk home insurance products with theft damage, civil liability, fire damage, aesthetic damage, etc, The health segment includes health insurance products under the Vivaz brand, The other insurance segment includes various products with stand-alone policies that are not linked to motor, home or health insurance, such as travel insurance for holders of credit cards and wellness insurance, and The other activities segment mainly relates to auxiliary insurance businesses and commissions.

Valuation ^Qas of 17 May 2024

Morningstar maintains a 3-star quantitative star rating for Linea Directa Aseguradora, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 1.09, in-line with our quantitative fair value estimate of 1.10. These shares have traded between a 21.29% discount and 6.96% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 88th percentile; in the financial services sector, the firm's score lies at the 91st percentile (meaning the shares are more undervalued than 91% of stocks in the sector)

Furthermore, Linea Directa Aseguradora maintains a quantitative valuation uncertainty rating of High. The company has held this star rating since the previous rating of 4, which was last assigned on 11/22/2023. The uncertainty rating for Linea Directa Aseguradora has remained High since the pre-

vious rating of Very High, which was last assigned on 12/26/2023.

The key factors behind these ratings are the company's earnings yield and volatility. The earnings yield is -0.37%, and its maximum annualized trailing 12-month volatility is 22.75%. The earnings yield falls at the 19th percentile in the financial services sector while the volatility is at the 30th percentile. Over the past year, the company's earnings yield has been between -1.23% and 6.25%; its volatility has ranged between 17.67% and 22.75%.

Economic Moat ^Qas of 17 May 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for Linea Directa Aseguradora falls at the 58th percentile in the financial services sector and at the 67th in the equity coverage universe. The company has maintained its None quantitative moat rating since after 08/17/2023, when it was downgraded from Narrow.

We also assign a Strong quantitative financial health rating to Linea Directa Aseguradora. The company's raw score on this metric, termed Distance to Default, ranks at the 87th percentile overall and 51st in the financial services sector. Furthermore, this financial health rating has stayed Strong over the last year.

Supporting these ratings are the company's enterprise value and annualized trailing 12-month volatility. The enterprise value of 1.25 billion, ranks at the 67th percentile in the covered equity universe and at the 80th percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 17.67%, falls at the 15th percentile in the universe and the 30th percentile in the financial services sector.





The earnings per share for Linea Directa Aseguradora are break-even. The firm maintains a dividend yield of 0.1%. We calculate the above figures over a trailing 12-month period.

Examining valuation further, the company's price-to-free cash flow ratio is 31.74, greater than 86% of its sector peers. These values are calculated using the stock's price at last market close.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
